The compliance process will include, amongst other things, screening of Customers and Vendors for presence of forced and child labour. If we discover evidence of slavery or human trafficking with any of our Customer and Vendor through this process and such Customer and Vendor refuses to comply, we will sanction from doing business with such Customer and vendor.

To maintain internal accountability, all relevant personnel will be trained to recognize environment, health, safety, and labour/worker concern, including issues relating to slavery, human trafficking and forced labour and to report and investigate all suspicions of improper conduct by Customers and Vendors.

The Company will develop its practices in respect of fighting against slavery and human trafficking with primary focus on areas of its business where there is potential risk of modern slavery. The company will provide training to employees relating to supply chain, with an increase emphasis, on risk related to modern slavery and human trafficking.
